

**INVESTMENT INSTRUCTIONS
FOR BOTH SHF FUND I AND ECOSHIELD BUILDING SYSTEMS**

**THE FOLLOWING INSTRUCTIONS ARE ONLY FOR INVESTORS WHO ARE
INVESTING LESS THAN \$200,000.00**

**IF YOU ARE INVESTING \$200,000 OR MORE SKIP THIS SECTION AND SCROLL
DOWN TO THE INSTRUCTIONS FOR THE INVESTORS WHO ARE INVESTING
\$200,000 OR MORE**

1. Read and Understand the Private Placement Memorandum (PPM), Company Agreement and Subscription Agreement.
2. SUBSCRIPTION BOOKLET
 - SIGNATURE PAGE – Fill out and Sign
 - INVESTOR INFORMATION QUESTIONNAIRE – Fill in requested information and check appropriate boxes.
 - ACCREDITED INVESTOR CERTIFICATE – Initial the appropriate blanks for items 1 – 10
3. ACCREDITED INVESTOR VERIFICATION – **Since you are investing \$200,000.00 or less you must have this section or the form filled out by your banker, CPA, Attorney, Investment Advisor or Broker-Dealer (“Independent Person”). You can either send the Subscription Document to the independent person or you can download or print the ACCREDITED INVESTOR VERIFICATION FORM which you will find in the Document section on our website (which can be found on the last page of either the EcoShield or Student Housing Fund sections in our website).**

Before sending the ACCREDITED INVESTOR VERIFICATION FORM to the independent person you should:

- Print your name in the blank marked “Investor.”
 - In the blanks below item 3 enter how you are investing i.e. as an Accredited Investor, trust, organization, family office etc.
 - PROFESSIONAL CAPACITY – please indicate the appropriate capacity of the individual verifying that you are “Accredited Investor” such as accountant, attorney, banker, etc. Then enter the appropriate information which pertains to them
4. **Alternatively, you may satisfy this verification section by providing a certified financial statement, bank account, investment account or previous two years of first two pages of tax returns showing earnings of \$200,000 per year for the past two years or \$300,000 per year for the past two years of combined spousal income.**

Once you have the Accredited Investor Verification section filled out or you have attached one or more of the alternative methods of satisfying this requirement you should then ensure that the rest of the Subscription Document is completed.

6. .BANK DEPOSIT AUTHORIZATION section – Provide the bank deposit information for the financial institution where you would like your distributions deposited.

- b. Completed and signed Accredited Investor Verification Information.
- c. Completed W-9 Form
- d. Copy of driver's license or passport
- e. Copy of Voided Check

 - ACCREDITED INVESTOR CERTIFICATE – Initial the appropriate blanks for items 1 – 10
3. ACCREDITED INVESTOR VERIFICATION – Investors who invest \$200,000.00 or more (can be spread over both EcoShield and SHF Fund I) are EXEMPT from this requirement as they are assumed to be Accredited due to the amount of their investment.

4. .BANK DEPOSIT AUTHORIZATION FORM – Provide the bank deposit information for the financial institution where you would like your distributions deposited.
